# **COMPANY & CHALLENGE**

Headquartered in Sweden, Nordic Juridik specialises in a wide range of business-law services to customers across Northern Europe. Through its expert services, the company helps businesses to operate safely, profitably and in compliance with international regulations.

Lawyers at Nordic Juridik work with huge volumes of documents, court papers, case files, emails, contracts, and much more. Previously, the company stored paperwork and printouts in secure cabinets at its head office—a practice which became unsustainable as people switched to remote working during the Covid pandemic. How could Nordic Juridik keep its operations running smoothly and provide effective access to essential documents?

Johannes Törnklev, Founder and Co-owner of Nordic Juridik, explains: "We looked at many digital document management solutions, and even tried creating our own platform using blockchain. But the solutions we tried had limited search capabilities, and very few could support indexed searching. As a workaround, we manually saved files with case numbers added to the filename to aid retrieval, but this was cumbersome and prone to errors."

"We reached a point where each team had developed their preferred solution, which made it hard to share files and information across the organisation," explains Johannes Törnklev. "What's more, with different revisions of the same files stored across multiple systems, version control became increasingly complex. We spent several hours each week identifying and manually deleting files to ensure to meet our data retention and legal hold policies."

### SOLUTION

For assistance in streamlining and simplifying document management, Nordic Juridik engaged Ricoh, which suggested adopting DocuWare as a standard solution for storage and collaboration. To accelerate the deployment, Ricoh helped Nordic Juridik to train the intelligent indexing capability in DocuWare to identify case numbers automatically from emails and scanned documents. Now, when the law firm receives incoming files, DocuWare identifies the case number and directs users to save files in relevant folders.

"Intelligent indexing makes managing our documents so much simpler, and federated access controls ensure that only employees with the right level of clearance access sensitive and confidential information," comments Johannes Törnklev. "Another plus is that DocuWare is compatible with Apple and Windows operating systems, which helps avoid compatibility issues when we share documents with clients that use different devices."

"With DocuWare we can work from anywhere with an internet connection and gain secure access to all the files we need," explains Johannes Törnklev.
